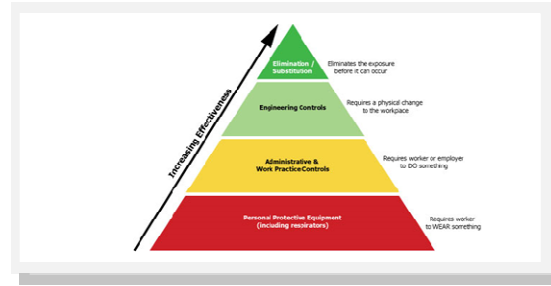

Topics for review include: history of industrial hygiene, calculations (TLV's, PEL's, other standards, TWA), sampling and analytical procedures for gases/vapors and particulates, ventilation, air pollution, industrial hygiene aspects of hazardous spill response, respiratory protection, heat stress, toxicology, personal protective equipment, operating principles of laboratory instruments, noise, ionizing and non-ionizing radiation, OSHA history/citation procedures, and management of industrial hygiene programs. Time will also be devoted to a review of selected industrial processes.

Daily testing will be used as a guide to individual learning. Self-study materials will supplement presentations and tests.

Includes two hours of Ethics.

At the end of this course, participants should be able to:

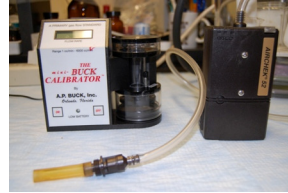
- Identify their own areas of strength and areas where independent study may be needed to prepare to sit for the exam.

Note: This is an overview course, not advanced Industrial Hygiene. A major aim of this course is to assist CIH exam takers to identify areas in which they are proficient and those in which they need more intensive study. Plan to allow 4-6 weeks following the class for additional study before taking the exam.
