### **Course Overview**

Workplaces present a variety of exposures that can cause illness and injury. Knowing what personal protective equipment (PPE) is right for the situation, how to use it, and if the employer is responsible for supplying it can be the difference between a healthy worker and a Workers Compensation claim.

Hazards will never be completely eliminated from the workplace; hence, OSHA's edict to employers: identify workplace hazards and ensure that employees are informed of their presence and how to protect themselves from harmful exposures. An employer's responsibility for protecting the worker is enhanced through the use of OSHA's hierarchy of controls: (1) engineering controls, (2) work practices, and (3) the default control of personal protective equipment (PPE). Unfortunately, there are still too many daily workplace incidents caused by the absence of and/or incorrect use of PPE. So let's get back to the basics.

This workshop addresses the general industry requirements of both California and Federal

OSHA with an emphasis on head, face, eye, body, hand, foot, and respiratory protection.
