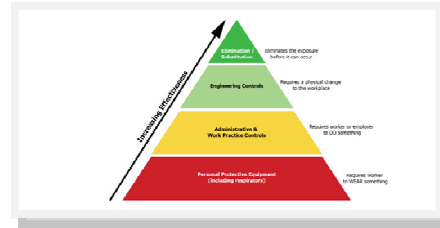

INTRODUCTION TO INDUSTRIAL HYGIENE

Course Overview

Industrial hygiene as a profession requires the recognition, evaluation and control of occupational health hazards within the work environment. For the safety/health professional, occupational health nurse, the environmental manager, and others working in related areas, this course provides a basic understanding of these concepts. Learn about the occupational activities that produce workplace hazards, the types of hazards and their physiological impact upon the worker, and methods of hazard reduction. Explore topics including personnel monitoring, identification of chemical and physical hazards, exposure standards, the relationship between exposure and health effects, industrial hygiene surveys and sampling, Cal/OSHA standards, and contemporary industrial hygiene issues. Gain new insight into the interrelationships between safety personnel, occupational health nurses, industrial hygienists and environmental managers to be able to recognize when the specialized skills of each are appropriate.

NOTE: Fundamentals of Industrial Hygiene (6th edition), Plog, B.A., et al., National Safety Council is **optional** companion course material – to **download a pdf of the optional chapters, details are provided on the course webpage. The publisher's download costs \$134.40, which enrollees must pay on their own.**
