### Where is the class? How do I get there? Where do I park?

Most courses are held at UCLA, in Westwood Village, near Downtown Los Angeles, and Anaheim. Prior to the class, you will be sent details of your class location along with a map, and driving, parking and walking instructions.

### What are your payment terms?

For courses for which registration fees are paid to the SCERC through **UC Regents.**Substitutions may be made without additional charge. Cancellations must be in writing.

#### Refund schedule:

Cancellation 15 or more business days before the class - 80% of registration fee
Cancellation 7-14 business days before the class - 50% of registration fee
Cancellation less than 7 days before the class and "no shows" - No refund


ROBERT PHALEN, PHD, CIH

JASMINE SCHLIESMANN-MERKLE, CHMM


